In compliance with the Monitoring Agreements included in the Industrial Facilities Tax Exemptions, Commercial Rehabilitation Exemptions, and the New Personal Property Tax Exemption, Karen Hebert, the City Clerk/Treasurer presented the annual reports of capital investment and employment for the eight firms currently receiving abatements.

The City Engineer reported on the City's investigation of a possible Coastal Zone Management Grant to enhance the access to the Thunder Bay River. The project would provide amphitheater style seating and an educational pavilion.
