North Industrial Tower and Pump Station Controls Recommendation

On November 15, 2016, the City received and opened proposals for the North Industrial Tower and Pump Station Controls. This work will include the repair and upgrade of the control system for the North Water Tower and Pumping Station. The remote monitoring and operations equipment is currently not functioning. Repairs are limited due to the age of the system and the original supplier no longer being in business and parts not being available. Monitoring and operation can only be performed manually at this time, which limits the ability to allow for adequate monitoring of the system and rapid activation in the event of an emergency.

Request for proposals were sent to various firms. Four firms attended the mandatory walkthrough of the project, and three proposals received as listed below:

Thunder Bay Electric, Alpena

\$39,840

Windemuller, Traverse City

\$33,581

J Rank Electric, Mt Pleasant

\$39,250

After review of the proposals by Mike Collins, City of Alpena Operations Supervisor of Suez Water – NA, and myself, it is recommended that Thunder Bay Electric be awarded the contract. Thunder Bay Electric is currently working on, or has completed two similar projects that will interconnect with this operating system. It is my opinion that utilizing Thunder Bay Electric will allow for the seamless addition of this upgrade into the existing control system they previously installed. As Thunder Bay Electric is a local contractor, it is anticipated that there will be a faster response time if we are experiencing any issues with the control system.

As this system was not having issues during the budgeting process, funding was not established for it's replacement in the current budget. However, the Water Fund -

Production Plant Capital Outlay budget will have a balance of approximately \$132,000 after completion of this year's projects. Thus funding can be transferred from this line item to the distribution capital outlay line item per the attached budget amendment.

It is my recommendation, as City Engineer, that the project be awarded to Thunder Bay Electric, Inc. for the proposed price of \$39,840.

The City of Alpena received (3) bids for the completion of upgrades to the controls/automation concerning the North Industrial Tower and Pump Station.

•	Thunder Bay Electric (Tempest Enterprises as programming subcontractor)	\$39,840
•	J.Ranck Electric (Perceptive Controls as programming subcontractor)	\$39,250
•	Windemuller	\$33,581

I recommend approving the bid from Thunder Bay Electric, even though they are not the lowest proposal. TBE is a local company that has done extensive work and projects at the WTP and throughout the City's Water System. Tempest Controls has also done a great deal of work at the WTP involving process control and automation. The North Industrial Project actually involve utilizing hardware and matching software on equipment that Tempest was the original contractor on this past summer. Both of these contractors understand the City's Water System and the details of the Project. Additionally, Tempest is also the subcontractor for the Low Service MC/VFD CIP which as awarded to Werth Electric earlier this month. These Projects are all related. Due to the precision and details that are involved in this type of programming it would be highly beneficial to have all the process control programming and automation for these Projects done by the same engineer, Tempest Enterprises. As mentioned before, TBE is local and can respond to any issues or concerns much faster than a company from out of town. This is critical when dealing with municipal asset and its ability to provide water to various parts of the System.
