ADVERTISEMENT

I. <u>Receipt of Proposal</u>

Sealed quotes on forms prepared by the Engineer will be received by the City of Alpena at 208 N. First Avenue, Alpena, Michigan, 49707, until 2:00 p.m. (local time) on Tuesday, April 23, 2024, for the supply of Ferrous Chloride Solution, Sodium Bisulfite Solution, Sodium Hydroxide Solution, Sodium Hypochlorite Solution, and Water Softener Salt in accordance with specifications and other documents prepared by the City of Alpena Engineering Department and Veolia.

II. <u>Proposals Will be Publicly Opened and Read</u>

At 2:00 p.m. (local time) on Tuesday, April 23, 2024, at 208 N. First Avenue, Alpena, Michigan, 49707.

III. Obtaining Contract Documents

Specifications and other documents may be obtained may be obtained on the City of Alpena website beginning on April 9, 2024.

IV. Owners Rights Reserved

The City of Alpena, hereinafter called the Owner, reserves the right to reject any or all proposals and to waive any formality or technicality in any proposal in the interest of the Owner.

INSTRUCTIONS TO BIDDERS

I. <u>Proposals Requested for Supply of</u>

The necessary materials, tools, and all of the equipment and labor necessary, and all utilities and transportation services required to perform and complete in workmanlike manner all of the work shown in accordance with drawings, specifications, and other contract documents prepared by the City of Alpena.

- A. <u>Form</u>: Each proposal shall be made on a form prepared by the Engineer and included as one of the contract documents and shall be submitted in a sealed envelope bearing the title of the work and the name of the Bidder.
- B. <u>Discrepancies</u>: In case of a difference between the stipulated amount of the proposal written in words and the stipulated amount written in figures, the stipulated amount stated in written words shall govern.
- C. <u>Modifications</u>: Proposals shall not contain any recapitulations of the work to be done. Alternate proposals will not be considered unless called for. Oral proposals or modifications will not be considered.
- D. <u>Examination of Contract Documents and Visit to Site</u>: Before submitting a proposal, Bidders shall carefully read the specifications and the other contract documents, shall visit the site of work and shall fully inform themselves as to all existing conditions and limitations and shall include in the proposal a sum to cover the cost of all items included in the contract documents.
- E. <u>Delivery of Proposals</u>: Proposals shall be delivered by the time and to the place stipulated in the Advertisement. It is the sole responsibility of the Bidder to see that his proposal is received in proper time. Any proposal received after the scheduled closing time for receipt of proposals shall be returned to the Bidder unopened.
- F. <u>Withdrawal</u>: Any Bidder may withdraw his proposal, either personally or by telegraphic or written request, at any time prior to the scheduled closing time for receipt of proposals.
- G. <u>Opening</u>: Proposals will be opened and publicly read aloud at the time and place set forth in the Advertisement.
- H. <u>Award or Rejection</u>: The contract will be awarded to the lowest and/or best qualified responsible Bidder complying with these instructions and with the Advertisement. The Owner reserves the right to reject any or all proposals or to waive any formality or technicality in any proposal in the interest of the Owner. No Bidder may withdraw his proposal for a period of 90 days after the date of opening thereof.

II. Interpretation of Documents

If any person contemplating submitting a proposal is in doubt as to the true meaning of any part of the specifications or other contract documents or finds discrepancies in or omissions from the drawings or specifications, he may submit to the Engineer a **written** request for an interpretation or correction thereof. All requests for information on the project shall be via, letter, written facsimile (989) 354-1709 or e-mail to <u>engineer@alpena.mi.us</u>. **No requests for information will be processed by phone.** The person submitting the request will be responsible for the prompt delivery. Any interpretation or correction of the documents will be made only by Addendum duly issued and a copy of the Addendum will be mailed or delivered to each person receiving a set of the contract documents. Neither the Owner nor the Engineer will be responsible for any other explanations or interpretations of the contract documents.

III. <u>Addenda</u>

Any addenda issued during the time of bidding or forming a part of the contract documents loaned to the Bidder for the preparation of his proposal shall be covered in the proposal and shall be made a part of the contract. Receipt of each Addendum shall be acknowledged in the proposal. Information requests shall follow the same procedure as above and must be received a minimum of five (5) working days prior to bid letting date for sufficient time to issue an addendum if warranted.

IV. Bidders Interested in More Than One Proposal

No person, firm, or corporation shall be allowed to make, file, or be interested in more than one proposal for the same work, unless alternate proposals are called for. A person, firm or corporation who has submitted a sub proposal to a Bidder or who has quoted prices on materials to a Bidder is not hereby disqualified from submitting a sub proposal or quoting prices to other Bidders.

V. Local Bidders Preference

The City reserves the right to enact the Local Bidders Preference if the City determines that bidders in question have first satisfied the conditions set forth by sections A through D of the "IX Award Process" section. The City may grant an award to a *qualified* local bidder/vendor as defined below for an amount equal to the lowest bid submitted meeting specifications. The following businesses shall be given the opportunity to lower their overall bid amount if they are within the following percentages:

A. Alpena City businesses:

Within 7% for projects under \$100,000 and 5% for projects at or over \$100,000

B. Alpena County businesses:

Within 5% for projects under \$100,000 and 3% for projects at or over \$100,000

City of Alpena businesses shall have priority over Alpena County businesses.

To be considered for local bidder preference, a local bidder/Vendor shall have met the following qualifications for at least one year prior to the date bid proposals are due:

- 1. Shall have a legal and permanent business address within Alpena County.
- 2. Shall be a personal property and real property taxpayer in Alpena County.
- 3. Shall be in compliance with all City Codes and Ordinances.
- 4. Shall not be indebted or in default to the City.

I. Description of Work

The work to be done under this contract will consist of the supply of Ferrous Chloride Solution, Sodium Bisulfite Solution, Sodium Hydroxide Solution, Sodium Hypochlorite Solution, and Water Softener Salt per the specifications contained herein to the City of Alpena, Water Recycling Plant, 210 Harbor Dr., Alpena, MI, 49707.

II. Completion of Work

If awarded Ferrous Chloride Solution, Sodium Bisulfite Solution, Sodium Hydroxide Solution, Sodium Hypochlorite Solution, and Water Softener Salt shall be available from July 1, 2024, through June 30, 2025. III. <u>Termination</u>

The City shall have the right to terminate this contract with a 30-day written notice to the other party. If the Contractor fails to maintain continuous work practices or delays completion of the project, the City may consider this default of the Contract.

Contractors in violation of City Ordinance at the time of the bid opening may be considered to be ineligible to contract with the City. The bid submitted by that bidder may be rejected by the owner who reserves the right to reject any or all proposals or to waive any formality or technicality in any proposal in the interest of the owner.

PROJECT SPECIFICATIONS

ITEM 1 – Ferrous Chloride Solution (FeCl2)

To be utilized in the control of phosphorus at the Alpena Water Recycling Plant.

Price quote must be per pound of iron FOB.

Price must be firm from <u>07/01/24 through 06/30/2025</u>.

Delivery is per tanker load not to exceed 5,000 gallons per shipment

The Ferrous Chloride Solution must be filtered to insure non-clogging of chemical feed pumps.

The City of Alpena purchases approximately 22,000 gallons of Ferrous Chloride Solution containing 18,000 pounds of iron per year.

ITEM 2 – Sodium Bisulfite Solution (NaHSO3)

To be utilized for de-chlorinating the Alpena Water Recycling Plant effluent.

Price quote must be **per pound of solution FOB**.

Price must be firm from <u>07/01/24 through 06/30/2025</u>.

Solution must contain 30%-38% Sodium Bisulfite.

To be shipped in plastic drums containing 55 gallons or less.

The City of Alpena purchases approximately 17,000 pounds of Sodium Bisulfite per year.

ITEM 3 – Sodium Hydroxide Solution (NaOH) Caustic Soda

To be utilized in the odor control scrubbers at the Alpena Water Recycling Plant.

Price quote must be **per pound of solution FOB**.

Price must be firm from 07/01/24 through 06/30/2025.

Minimum solution concentration 50%.

Produced by membrane cell or diaphragm cell only, please state method of production with bid. [Mercury cell process is non-acceptable]

Delivery is per tanker, not to exceed 1,200 gallons (14,000 pounds) per shipment.

The City of Alpena purchases approximately 24,000 pounds of Sodium Hydroxide solution per year.

ITEM 4 – Sodium Hypochlorite Solution (NaOCL) Industrial Bleach

To be utilized in the odor control scrubbers and for disinfecting the Alpena Water Recycling Plant effluent.

Price quote must be <u>per gallon of solution FOB.</u> Price must be firm from <u>07/01/24 through 06/30/2025</u>. The solution must contain a minimum of 1.26 lbs. of chlorine per gallon. The solution must be shipped as fresh as possible. The product manufacture date must be evident.

Delivery is per tanker load not to exceed **4,100** gallons per shipment.

The City of Alpena purchases approximately 16,400 gallons of NaOCL per year.

ITEM 5 – Water Softener Salt Sodium Chloride

To be utilized in the odor control scrubbers at the Alpena Water Recycling Plant.

Price quote must be **per bag of pellets FOB (indicate bag size on bid)**. Price must be firm from **07/01/24 through 06/30/2025**. Delivery is per 49 bag lot (individual bags not to exceed 50 pounds per bag). The City purchases approximately 196 bags of water softener salt per year.

MEASUREMENT AND PAYMENT. The completed work of furnishing and delivering Ferrous Chloride Solution, Sodium Bisulfite Solution, Sodium Hydroxide Solution, Sodium Hypochlorite Solution, and Water Softener Salt will be paid for at the contract unit prices for the following contract items (pay items):
